The issue of the transfer of GPIC remaining assets was thoroughly discussed. One more
time all aspects of the issue and mechanisms for solving were discussed. It was agreed
that the list of remaining assets will be updated with the purpose of more visualization.
The following options were discussed: transfer if remaining issues to NCDC with their
further distribution; in close communication with the GF detail study of the grants close

out requirements. The notion of addressing the GFATM with the request to explore the possibility to extend the deadline for grant closure (transfer of the assets) with the purpose of the best possible regulation of the issue was raised and agreed. It was agreed that the issue will be out into the agenda of upcoming 72nd CCM meeting scheduled for August 1, 2014.

- While discussing NFM planning document it was decided that at the next CCM meeting
 the members the document will be discussed and the timeframe of its approval will be
 agreed.
- While discussing the proposal on Technical Assistance for HIV/AIDS concept note development to be submitted to the French 5% Initiative it was decided that the Secretariat will present the draft application to the members at the next CCM meeting for approval. The members will be asked to submit the application in August 2014
- The "wiliness to pay" of NFM was discussed. It was agreed that the issue of the sum to be envisaged in the 2015-2017 State Budget under "Wiliness to Pay Requirements" of NFM and its reflection in MTEF will be presented by NCDC and broadly discussed at the 72nd CCM meeting
- HIV prevention service package for MSMs, FSW, IDUs was discussed. It was decided
 that the issue of revision of the package will be discussed with relevant stakeholders.
